- **No products can be raffled off or games of chance offered.** Free drawings for products are permitted
- (2) Exhibitor passes will be provided per day for each space purchased. Additional passes may be purchased from the Fair Office.
- Parking allowed in designated areas.
- EVERY ARTICLE ON EXHIBIT SHALL BE AT ALL TIMES UNDER THE CONTROL OF THE SUWANNEE COUNTY FAIR ASSOCIATION. EVERY PRECAUTION WILL BE TAKEN FOR THE SAFE KEEPING OF SAME. HOWEVER THE SCFA WILL IN NO CASE BE RESPONSIBLE FOR ANY LOSSES, DAMAGE OR INJURIES TO THE EXHIBITOR, HIS AGENTS OR REPRESENTATIVES. THE EXHIBITOR SHALL HOLD THE SCFA HARMLESS AND AGREE TO INDEMNIFY SAME FROM THE NEGLIGENCE OR FAULT OF THE EXHIBITOR. IT IS REQUIRED THE EXHIBITOR CARRY INSURANCE ON HIS MERCHANDISE.
